

2008/2009 Statistics at a Glance

Early Childhood & School Age Programs

- Provided full-day child care to 182 children in the Rodie Child Care Center (Upper Saddle River) and Valley Hospital Corporate Childcare Center (Ridgewood)
- Provided academic programs to 165 children in YWCA nursery schools in Ridgewood, River Edge, and Upper Saddle River
- Provided 180 children with enrichment classes in the Fun For Kids program
- Provided before and after school supervision and fun for 1,363 youngsters in 26 program sites (including four after-kindergarten programs) throughout Bergen County
- Served 870 campers at four summer camps located in Saddle River, Dumont, and Harriman, NY
- Enabled 1,500 working parents to pursue their professional and economic goals, knowing that their children were well cared for while they were at work
- Provided \$75,770 in financial assistance to 50 child care and summer camp participants

Aquatics

- Provided American Red Cross swimming lessons to 1,846 swimmers age 17 and under and to 148 adults
- Provided therapeutic and rehabilitation programs to 80 participants in aqua-therapy and arthritis classes

Fitness & Dance

- 236 adults and 46 seniors improved their health and fitness in YWCA Body Shop, exercise, and aqua-fitness programs
- Provided dance instruction to 136 aspiring ballerinas and judo instruction to 76 children
- Enabled 1,000 members of the Bolger Fitness Center to maintain exercise and weight training regimens designed to keep them fit and healthy

Special Needs Programs

- Provided 64 mentally and physically challenged individuals from six months to adulthood with adapted swimming and sports programs

Community Enrichment & Support

- Newcomers Club welcomed 236 new residents and their families to the community and provided programs to help them forge new relationships
- Women's Empowerment (WE) Series provided intellectually stimulating seminars to over 130 women, and writing workshops inspired 36 women to express themselves in fiction and non-fiction
- Women for Sobriety, a self-help network for women with addictions, provided support to an average of 15 individuals each week

Rape Crisis Center

- Provided 24/7 crisis intervention to 1,192 callers on the rape crisis hotline
- Accompanied 61 individuals who were sexually assaulted or abused to hospitals, emergency rooms, law enforcement agencies, and/or legal proceedings
- Presented 122 educational programs aimed at preventing sexual violence and promoting healthy relationships in venues throughout Northern New Jersey

Tribute to Women and Industry (TWIN)

- Honored 30 women for their professional achievements and the 20 companies that supported their career advancement
- Since 1974, TWIN has honored 1,804 women and 213 corporations throughout Bergen, Essex, Hudson, and Passaic Counties in NJ and Rockland County in NY

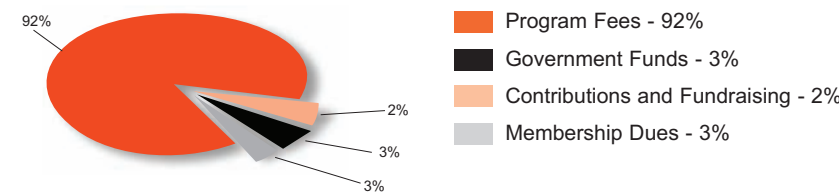

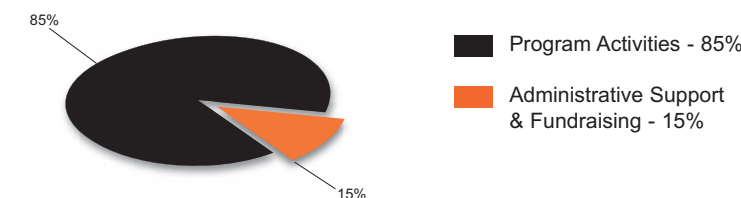

2008/2009 YWCA Bergen County Annual Report

Dear YWCA Friends,

No one would argue that 2008/2009 was a tough year. However, we are proud to report that it was a year in which the YWCA Bergen County and our staff, members, and volunteers persevered—and even flourished—in our efforts to empower women and eliminate racism in the face of very difficult economic circumstances.

In 2008, the YWCA renewed our commitment to moving forward with the Year 2 initiatives set forth in our 5-year Strategic Plan, before we were even aware of the impending economic crisis. As the year unfolded, funding and program enrollment challenges required us to re-examine priorities, but in some cases we were successful in coming up with fresh approaches to achieving our goals. For example, we continued to develop programs to help girls build self-esteem and self-confidence, launching a brand new “Girl Power” camp in July 2009 that gave girls ages 11-14 an empowering summer camp experience. We also initiated a new effort aimed at promoting increased racial understanding across the entire community, hosting the first-ever Stand Against Racism day in Bergen County in April 2009.

We would like to take this opportunity to acknowledge the YWCA members for their loyalty and continued participation in our programs. Despite the fact that many families were forced to cut back on non-essential expenditures, our swimming and fitness programs had higher revenues over the past 12 months than in prior years. And working parents who rely on the YWCA’s before and after school programs to care for their children have continued to utilize these programs—even while out of work and searching for new jobs.

The YWCA has been a vital resource for Bergen County residents for nearly 90 years, through good times and bad. As the economic picture begins to show signs of improvement, we look forward to continuing to expand our services and work together with our community to eliminate racism and empower women, girls, and their families.

Rising to the Challenge



In the sea of challenges presented by the recent economic crisis, the YWCA Bergen County not only stayed afloat—we forged ahead with our mission of empowering women and eliminating racism. Benefiting from diversified programming and income streams, we weathered tough times and focused on positioning the YWCA for better times ahead. The following are highlights from our 2008/2009 fiscal year.

YWorry-Free Child Care Empowers Parents

Providing quality child care empowers working parents by giving them the security of knowing their children are safe, happy, and educated.

This year our YWCA continued its efforts to expand the reach of its child care services and to ensure that they are affordable to Bergen County families. Given the extraordinary economic circumstances, this was no easy task. As demand for financial assistance grew, funding for scholarships decreased. However, we increased the number of sites where we provide before/after school care from 24 to 26. By keeping costs low and providing financial assistance to needy families, our YW helped make summer camp a reality for 13 families (18 children) who could not otherwise have afforded it. And as we prepared to launch our new “Girl Power Camp” (which debuted in July 2009), we were able to offer \$4,560 in scholarships so that 11-to-14-year-old girls could enjoy this unique, self-esteem building experience.

YWellness Makes a Difference

For our YWCA, being there for our community involves being committed to delivering relevant, high-quality health and wellness programs for women, girls, and their families.

The recession forced us to re-assess plans to roll out an array of new programs—but we decided we would not be completely deterred by the economy. Swimmers of all ages filled our American Red Cross Swim classes, eager to learn “skills for life.” We expanded our girls programs, adding “Girls Walking Strong”, an indoor walking program, and “Pre-Season Sports Skills and Conditioning” to our existing roster aimed at helping pre-teens develop healthy body images and build self-esteem. We grew our adult indoor walking program and added land and water-based cardio classes that promote women’s heart health. And, as demand remained strong for specialty programming such as aqua-therapy and special needs swimming, we launched “Get in the Swim”, a no-fee program for cancer survivors that provides swim lessons and support.

YWorks for Change

The YWCA has a 150 year history in social action and advocacy, and our YW carries on this tradition to meet our twin goals of empowering women and girls and eliminating racism.

For example, we and our YWCA sisters across the country cheered on January 29th, 2009 as President Obama signed his first major piece of legislation: the Lilly Ledbetter Fair Pay Act. The YWCA lent its collective voice to Ms. Ledbetter’s victorious fight to convince Congress to counteract a Supreme Court ruling that required employees to file pay discrimination claims within 180 days of receiving the first discriminatory paycheck. The resulting law enables individuals to challenge ongoing pay discrimination and protects employees from workplace discrimination. On April 3rd, 2009, we built on the work our YW has done to promote increased racial understanding from within our organization and took our mission to the streets, hosting a community-wide Stand Against Racism. A regional YWCA initiative aimed at raising awareness about discrimination and celebrating diversity, the Stand Against Racism was launched in 2008 by the YWCA’s of Trenton and Princeton. This year, our YW was joined by close to 20 businesses and organizations plus local legislators, community activists, students, and area residents for an event that was the first of its kind in Bergen County—and which promises to be the first of many.
